## Agreement

This is an agreement between the Consignee (hereafter "Buyer") and CAR FROM JAPAN CO., LTD. regarding the purchase of vehicle **Daihatsu Hijet Truck 1990 Chassis No. S81P-152** [REDACTED]

### Payment Information

The Buyer must pay the full invoiced amount for vehicle(s) mentioned in the invoice and send T/T copy to CAR FROM JAPAN CO., LTD. or its affiliates (hereafter "CAR FROM JAPAN"), following the PAYMENT TERMS & CONDITIONS. The Buyer shall bear necessary bank transfer charges. CAR FROM JAPAN guarantees handover of the related product(s) upon receipt of full price within the deadline.

Upon receipt of the T/T copy within the deadline, CAR FROM JAPAN will conduct reservation extension of the car and notify you about reservation completion. The reservation extension will be for 72 hours from the valid T/T copy received time. This time is for the payment to reach CAR FROM JAPAN's Bank in Japan.

### Cancellation Terms

Upon buyers' inability of fulfilling PAYMENT TERMS & CONDITIONS, the deal will be cancelled. Buyer can also ask for cancellation. In case of cancellation after CAR FROM JAPAN has confirmed the transaction (full or partial payment confirmation), CAR FROM JAPAN will charge 50% of the invoiced amount or \$2,000 per car, whichever higher, as a cancellation fee. CAR FROM JAPAN will send the refund amount to the Buyer, after deducting the charges, at Buyers bank cost.

In case of order cancellation after CAR FROM JAPAN has shared the shipping schedule with the Buyer, no refund will be available.

In case the buyer is unable to provide necessary information for paperwork related to export or delivery of the car to the buyer within 30 days from the payment confirmation date, the transaction is considered canceled from the buyer side and buyer will be charged according to the terms and conditions.

After CAR FROM JAPAN have received the payment of invoiced amount within deadline, if CAR FROM JAPAN cancels the deal for unavoidable reasons (for example, natural disaster, the product has been damaged or not available), CAR FROM JAPAN will refund the Buyer 100% of the amount received, and CAR FROM JAPAN will bear the bank cost for the refund.

### Vehicle(s) Condition

CAR FROM JAPAN presents information about the condition and function of vehicle(s) accurately, to the best of its ability and knowledge. By purchasing vehicle(s) from CAR FROM JAPAN, the Buyer understands and agrees that the vehicle(s) might be an USED one, the conditions are described as honestly as possible, and vehicle(s) are not guaranteed to be same as the image the Buyer might have about the vehicle(s). The Buyer cannot put forth a claim on the vehicle(s) condition upon delivery.

### Standards / Laws of Importing Countries

The Buyer will be responsible to confirm the import laws and customs duties with the authorities in the importing country before they make a purchase from CAR FROM JAPAN. CAR FROM JAPAN will not be responsible for any claim related to such rules.
